S Pre-Scheduling Checklist

For Club VP of Rec / Scheduler:

- 1. Team Continuity & WYS ID:
 - Teams with ≥60% returning players and coaching staff: retain current WYS Team ID.
 - New teams or teams with <40% continuity: request new WYS Team ID.

2. Assess Team Placement:

- Review previous season performance (skill, coaching, roster) for appropriate bracket.
- Evaluate any teams that played up an age group in 2024.

3. Age Group Validation:

• Use the 2025-2026 Birth Year – Season Matrix to confirm team eligibility.

4. Coach/Manager Info:

 Ensure each team has a clearly identified point of contact (Coach, Manager, or Assistant Coach).

5. Team Naming:

 Uniform team names must follow NSYSA naming conventions (reference NSYSA Registrar for guidance).

For Club Registrar:

- Confirm all teams are assigned appropriate age groups and designated contacts.
- Use the Competitive Play Application (path: **Registrar > Applications > Competitive Play**) to identify U10–U18 teams seeking competitive brackets.
- Enter and annotate **critical scheduling conflicts** (e.g., no Sunday play, dances, AP/SAT/ACT tests, Rec Cup, field limitations) in the NSYSA team "Comments" section.
- Flag coach conflicts and dual-team coaching scenarios by August 13.
- Mark teams "Ready to Schedule" in NSYSA no later than August 13, 5:00 PM.

Scheduling Considerations

Conflicts to Note:

- Coaching multiple teams (indicate priority and both teams assistant coach support).
- Preferred time slots (AM/PM) or field availability.
- Known conflicts:
 - o SAT Test Dates: Sept. 13, Oct. 4, Nov. 8, Dec. 6
 - ACT Test Dates: Sept. 6, Oct. 18, Dec. 13
- Travel time expectations (unless clearly permitted):
 - Teams traveling >1 hour will **not be scheduled before 10:00 AM** for away games.
 - Away matches should end by **6:00 PM**.

Scheduling Prep Requirements

- All rosters balanced and assigned to teams.
- Every team must have a registered coach (VP/Club Pres. cannot cover multiple teams).

• Review and understand the NSYSA Schedulers Toolkit including your club's field inventory.

🚯 Waivers & Roster Adjustments

- Submit <u>Medical Play Down Waivers</u> and Roster Modifications in advance to NSYSA Board (cc NSYSA <u>Board email</u>).
- Waiver procedures available online.

Z Tournament Participation

- Submit <u>Tournament Team Identifier Form</u> (2024 version) at the scheduling meeting for any teams seeking tournament exemptions.
- Only tournaments sanctioned by NSYSA, WYS, or USYS may interfere with League play.

😒 Referee Payment Details

U11 and Above (Full-Sided):

 Refer to current NSYSA & Kitsap Peninsula Soccer Referee Association <u>Agreement</u> for rates and billing.

U10 and Below (Small-Sided):

- NSYSA will pay referees directly; clubs will be billed.
- Clubs must submit monthly game reports to NSYSA Treasurer.

S NSYSA Scheduling Fees

- Clubs will receive monthly invoices from NSYSA Treasurer.
- Payment is **due within 30 days** of billing date.
- No payment required at the scheduling meeting.
