

# Northwest Sound Youth Soccer Fall 2024 Recreational Scheduling Meeting

**TL;DR** – It’s time for Club Registrars and Schedulers to get ready for the NSYSA Fall Scheduling meeting, 1PM Saturday, August 10, in-person at Round Table Pizza, Silverdale.

Thank you in advance for successfully registering players, identify and recruiting coaches and team staff, and training a growing number of small sided and referees.

In anticipation of the **August 10, 2024, 1:00 p.m.** NSYSA Fall Scheduling Meeting held in person at Round Table Pizza, 3276 NW Plaza Rd #101, Silverdale, WA (NO Hybrid/Zoom option offered)...

A. Pre-Scheduling meeting requirements:

1. Club VP of Competition/Scheduler.
  - a. Determine if a team is continuing from last year (60%+ returning players and core coaching staff) or the team is largely comprised of new players and/or core coaching staff.
    - i. Teams with 60% or more players from the previous year retain WYS Team ID #.
    - ii. New teams or teams with less than 40% returning players obtain new team WYS Team ID #.
  - b. Identify continuing team’s strengths and weaknesses carried over from last season (coaching may factor higher than players rostered or 2023 past standings due to past COVID and gap-seasons.)
  - c. Review all teams that played up an age bracket. Determine correct placement for 2023. (Ref. 2023-2024 Birth Year – Season Matrix on last page of this document)
  - d. Work with your Club Registrar to have team POC (Point of Contact), be it the Coach, Manager or Assistant Coach, correctly and completely identified for each Team.
2. Club Registrar reviews all administrative requirements. (Reference NSYSA [FAQ page](#) (with video) and Registrar’s [notebook](#))
  - a. Reference [Birth Year Player Age matrix](#) to determine authorized team levels, i.e. 2019 = U06 and 2006 = U19.
  - b. Remember Matriculate or advance each team’s age one year from previous year!**
  - c. Identify new teams.
  - d. Clubs identify U10-U18 teams which desire to participate in the Competitive Bracket for play utilizing the Competitive Play [Application](#) (path: **Registrar > Applications > Competitive Play**).

**Note:** Please use the following nomenclature for naming teams:

3. Clubs identify all known critical dates which may impact schedule (i.e. desire for no Sunday play, School AP / SAT Testing, School Dances, Recreation Cup, field conflicts, etc.)  
Encourage and Save these Dates with your Teams:

- a. **Soccer to the Max – DATE “First Weekend of October” (plan to participate: Sun. Oct 6, 2024)**
- b. **Recreational Cup - REC CUP NSYSA begins Round Robin play Nov. 16 & 17, 2024]**

### Coaching conflicts:

4. Requested scheduling considerations must be noted in managed Teams “Comment” area **prior** to marking Teams as “Ready to Schedule”.
  - a. Club Registrar will have annotated “Comments” in the NSYSA manager Teams section requesting scheduling considerations **prior** to **end of business** August 8, 2024.
  - b. When coaches have multiple teams, Club Registrar will have annotated “Comments” in the NSYSA manager Teams section for each team requesting scheduling considerations **prior** to August 8, 2024.
5. Note: Requests for **“No Sunday Games” cannot be assured.**
  - a. Examples of expected Comments include:
    - i. AM / PM requests. (e.g. “AM games; also coaching team 440263993” or “Prefer home games on Sunday’s if necessary”)
    - ii. Multiple team commitment, (Coaches with multiple teams must identify Assistant Coach and/or substitute team staff to reduce scheduling unavailability) Annotated for each team.
    - iii. Work Schedule conflicts.
    - iv. Local school: dances, known field conflicts, etc.
    - v. Known SAT Testing Dates: **October 5, 2024, November 2, 2024 and December 7, 2024**
    - vi. Known ACT Testing Dates: **September 14, 2024, October 26, 2024, December 14, 2024**
6. Teams traveling greater than one hour will not expect to have away matches scheduled earlier than 10:00 AM and can expect that distant away matches will be completed by 6:00 PM
7. Club VP of comp has assigned assistant coach and additional team staff will support coaches having conflicts.

### B. Scheduling Requirements:

1. Team rosters correctly assigned with balanced numbers on all teams.
2. Teams registered must have a Coach assigned.
  - a. Those teams without coaches must have a club representative registered to each team to be scheduled. (This may affect multiple teams until coaches are assigned)
3. **Club Registrar shall have updated each team on the NSYSA web site as “Ready to be Scheduled” not later than end of business August 8, 2024 in preparation of the scheduling meeting.**
4. Club Schedulers have downloaded current NSYSA [“Schedulers Tool Kit”](#) reviewed both Instructions and your Club’s inventory of fields for correct and complete understanding.

### C. NSYSA Waiver Information:

1. Clubs shall have previously submitted Washington State Youth Soccer Medical Play down Waivers for review with cc: to the NSYSA Board for notification of pending approval. [Forms and procedure on-line.](#)

2. Clubs shall have previously submitted requests for roster modification to the NSYSA Board for consideration and approval.
- D. Tournament Play Schedule Consideration Requests: Clubs shall present a completed 2023 version of [Tournament Team Identifier form](#) at the Schedule meeting for teams requesting exemption to attend any sanctioned tournament that could impact NSYSA League play. No team may participate in any tournament not sanctioned by NSYSA, WYSA, or US Youth Soccer which will impact League play.
- E. Referee Payment U11 & Above – Full Sided Game:
1. Reference current [NORTHWEST SOUND YOUTH SOCCER ASSOCIATION & KITSAP PENINSULA SOCCER REFEREES ASSOCIATION AGREEMENT OF UNDERSTANDING](#) for current Fee Schedule, Billing and Payment procedures.
- F. Referee Payment U10 & Below – Small Sided Game:
1. For those Clubs participating in the NSYSA 2023 Fall Soccer U10 & Below League season, Clubs will verify payment schedules in advance. NSYSA will be handling referee payments. Reference [workflow](#) chart.
  2. Clubs will generate a report for the prior months period of games and will forward to the NSYSA Treasurer.
    - a. NSYSA Treasurer will pay the referees and apply a charge to individual Clubs for the cost.
- G. NSYSA Scheduling Fees:
1. Payment is not required at time of the NSYSA Schedule meeting.
  2. Clubs will be provided an invoice following the Scheduling Meeting
  3. Payment is due thirty days after billing date.
- H. Recreation Cup:
1. Each Club shall be prepared to offer to host specific ages and brackets of the NSYSA Recreation Cup.
  2. Tournament format will be begin November 16, 2024
  3. Semifinals and finals will be played after **[date TBD]**. Specific game dates are **TDB**
  4. Clubs shall provide the Recreation Cup Director Club Points of Contact (POC). Name, address, and phone numbers shall be provided prior to the sixth week of League play.
  5. Player participation will be accepted for teams of each playing year solely. Teams with older players desiring to play at lower age brackets must remove the older players by the roster freeze date.

- I. Soccer to the Maxx
1. Soccer to the Maxx is scheduled **DATE is Sunday October 6, 2024.**
  2. Age brackets will be determined based on NSYSA Club support.
  3. Clubs shall be prepared to host teams for specific ages and gender.

- C. By not later than August 18 the “*Begin Scheduling*” direction will – hopefully! – be sent from NSYSA Scheduler to all Club Schedulers.
- D. By not later than August 30 at 5:00PM Club home schedules will be returned to NSYSA Scheduler.
- E. Goal is that Fall 2024 Schedules will be posted September 3 for public viewing.
